Proposed Elevations

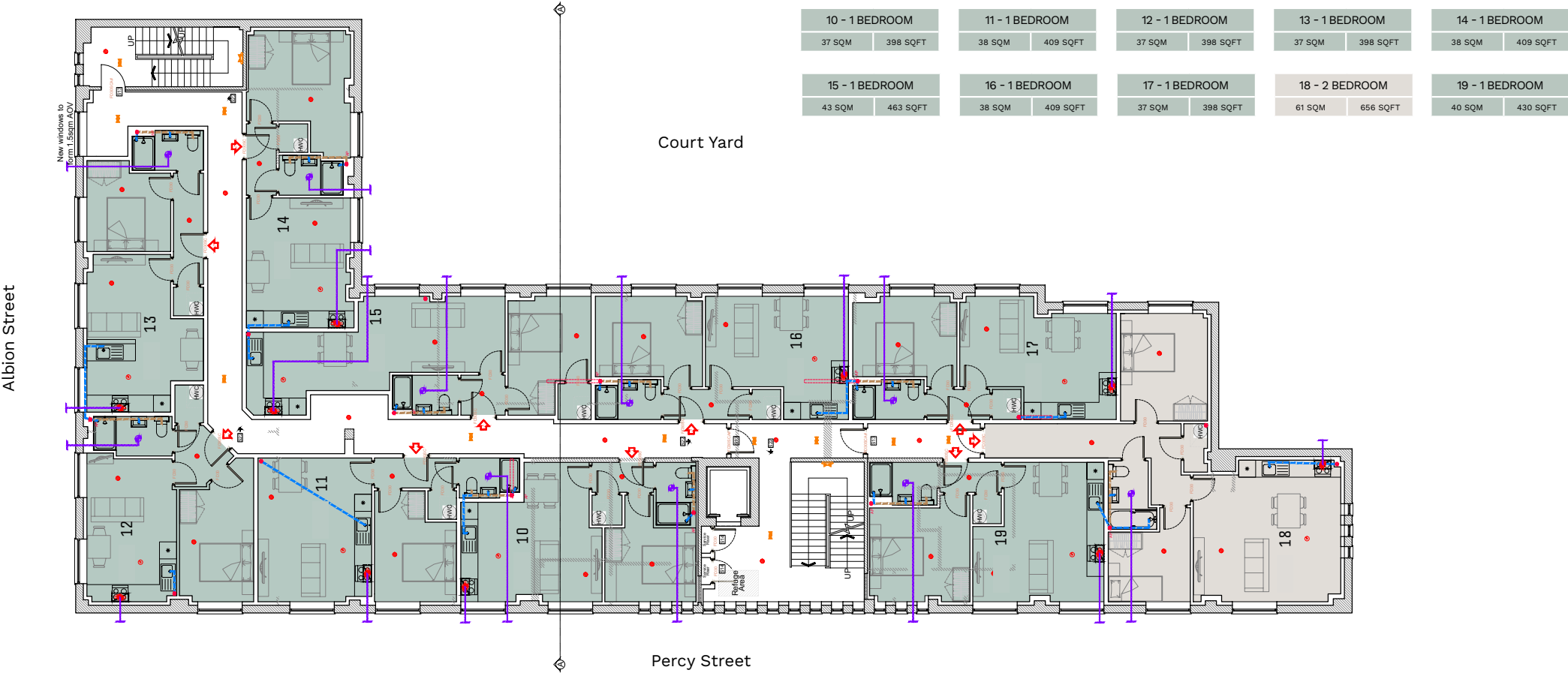

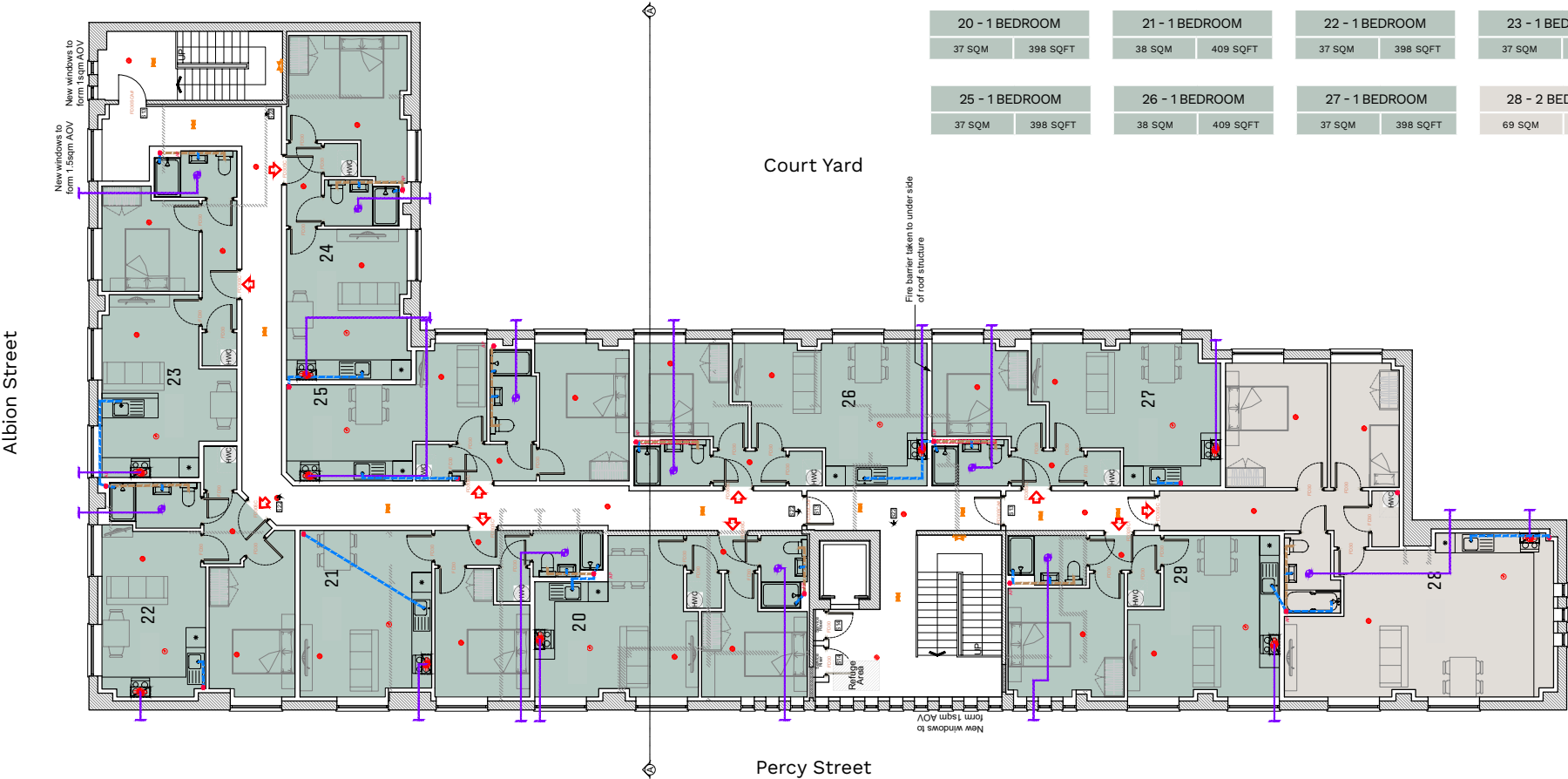
